First AID MEASURES: -

4.1. Description of first aid measures







First aid personnel should pay attention to their own safety. If the patient is likely to becomeunconscious, place and transport in stable sideways position (recovery position). Immediately remove contaminated clothing. Show container, label and/or safety data sheet to physician.

If inhaled:

Keep patient calm, remove to fresh air, seek medical attention.

On skin contact:

Wash thoroughly with soap and water.

On contact with eyes:

Wash affected eyes for at least 15 minutes under running water with eyelids held open.

On ingestion:

Immediately rinse mouth and then drink 200-300 ml of water, seek medical attention.

4.2. Most important symptoms and effects, both acute and delayed

Symptoms: The most important known symptoms and effects are described in the labelling (see section 2) and/or in section 11., Further important symptoms and effects are so far not known.

4.3. Indication of any immediate medical attention and special treatment needed

Treatment: Treat according to symptoms (decontamination, vital functions), no known specific antidote.

FIRE-FIGHTING MEASURES: -

5.1. Extinguishing media

5.2. Special hazards arising from the substance or mixture

5.3. Advice for fire-fighters

Special protective equipment:

Wear self-contained breathing apparatus and chemical-protective clothing.

Further information:

In case of fire and/or explosion do not breathe fumes. Keep containers cool by spraying with water if exposed to fire. Collect contaminated extinguishing water separately, do not allow reaching sewage or effluent systems. Dispose of fire debris and contaminated extinguishing water in accordance with official regulations.

ACCIDENTAL RELEASE MEASURE:

6.1. Personal precautions, protective equipment and emergency procedures

Use personal protective clothing. Avoid contact with the skin, eyes and clothing. Avoid dust formation.

6.2. Environmental precautions

Do not allow contamination of public drains or surface or ground waters. Inform local water plc if spillage enters drains and the Environment Agency (England & Wales), the Scottish Environmental Protection Agency (Scotland), or the Environment and Heritage Service (Northern Ireland) if it enters surface or ground waters. Keep people and animals away.

6.3. Methods and material for containment and cleaning up

For small amounts: Contain with dust binding material and dispose of. For large amounts: Sweep/shovel up.

Avoid raising dust. Cleaning operations should be carried out only while wearing breathing apparatus. Dispose of absorbed material in accordance with regulations. Collect waste in suitable containers, which can be labeled and sealed. Clean contaminated floors and objects thoroughly with water and detergents, observing environmental regulations.

7.1. Precautions for safe handling

No special measures necessary if stored and handled correctly. Ensure thorough ventilation of stores and work areas. When using do not eat, drink or smoke. Hands and/or face should be washed before breaks and at the end of the shift.

Protection against fire and explosion:

Dust can form an explosive mixture with air. Avoid dust formation. Prevent electrostatic charge - sources of ignition should be kept well clear - fire extinguishers should be kept handy.

Respiratory/Skin sensitization

Assessment of sensitization:

There is no evidence of a skin-sensitizing potential.

Experimental/calculated data:
